

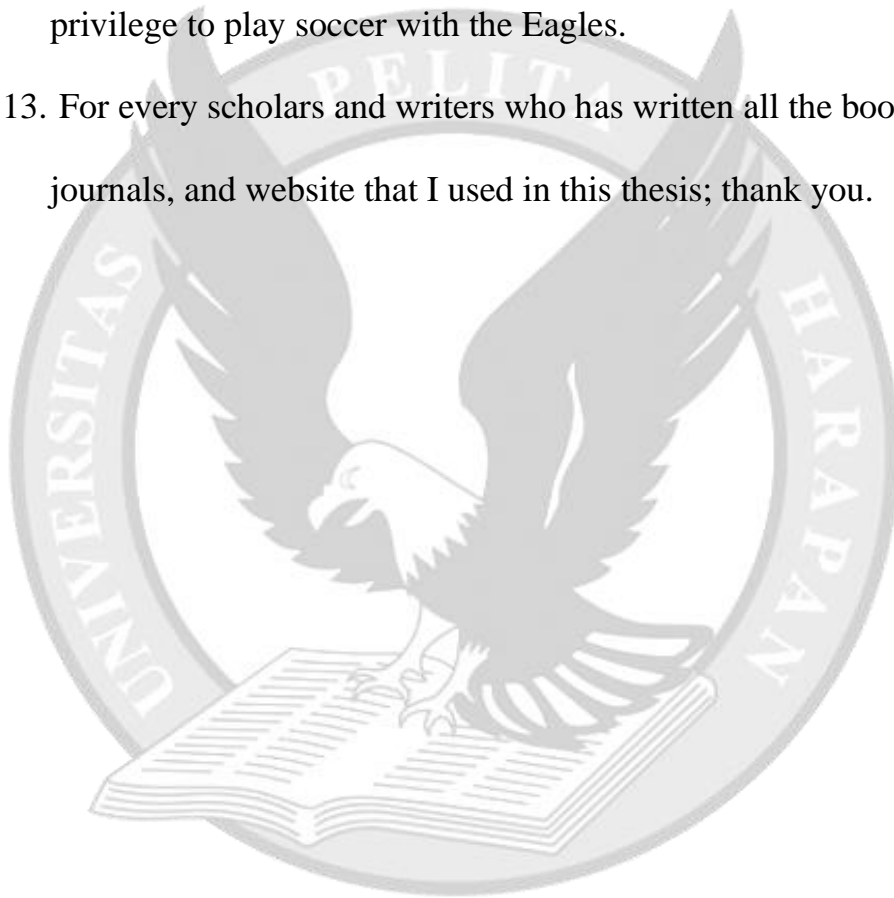
## PREFACE
