# **CHAPTER I**

## INTRODUCTION

## 1.1 Background of the Study

Business success is measured by the entrepreneur's competencies and will affect the business performance success directly. The important factor affects business performance where entrepreneurs have the skill, knowledge, creativity, and quickly catch an opportunity in the initial stage and future stage to impact business success.

Entrepreneurship is a process that someone established and organized his or her business which can affect the business performance. An entrepreneur is someone who risk taker and work under uncertainty for achieving the goal (Trammel, 2015). Entrepreneur in achieving a goal need have ability to build something from nothing and make innovative and creative products and services to fulfill the customers' needs.
