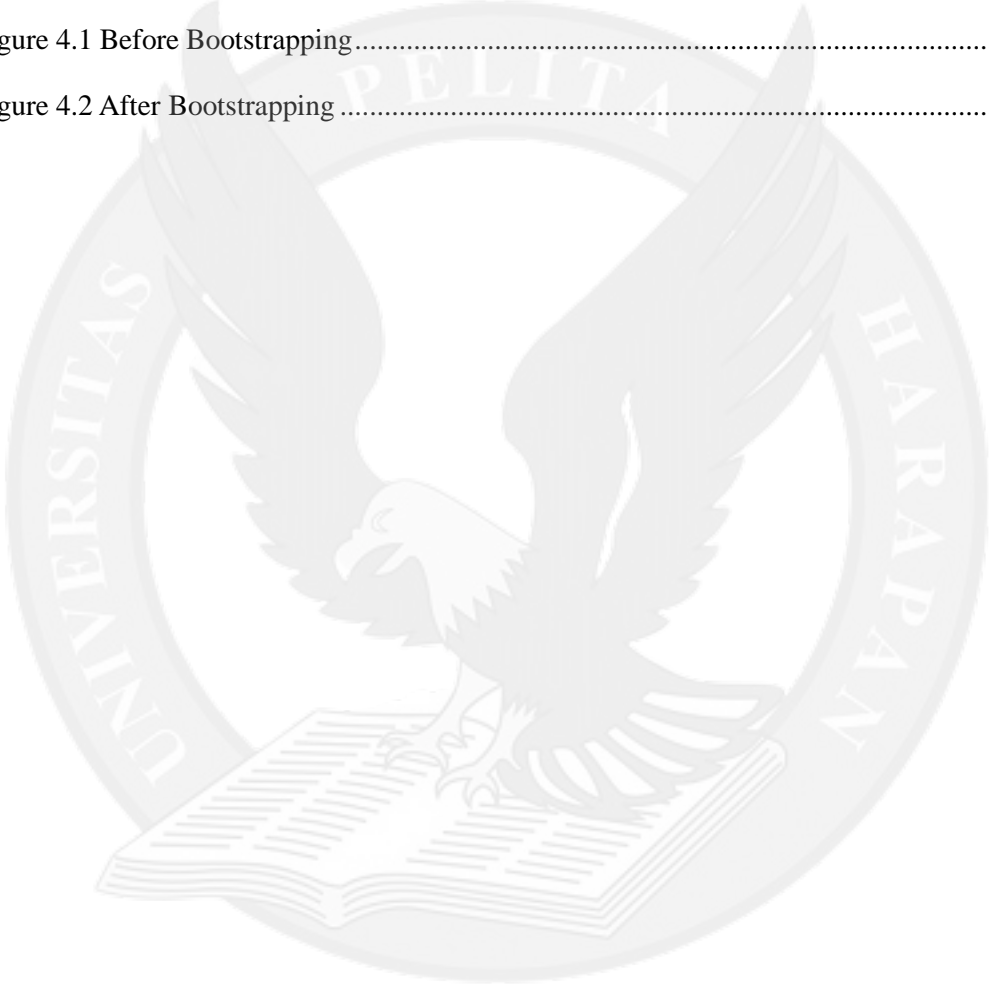
Figure 1.1 Number of Smartphone users worldwide.....2
