The position of the MPS Pilkades is functionally a special institution (ad hoc) who exercise the authority of the Regent in resolving disputes the results of the Village Chief Election as referred to in Article 37 paragraph (6) Law No. 6 of 2014 concerning Villages. MPS Pilkades is an innovation from the Regional Government West Sumbawa Regency. However, in settings related to the position and the authority of the MPS Pilkades, several problems have arisen that can weaken the MPS Pilkades and threats to social integrity in villagers. This study uses a normative juridical research method with empirical juridical support. Approach used are the statutory approach, the case approach, the historical comparisons and approaches. Based on research results carried out, it can be seen that in the regulation regarding The existence, position and authority of the MPS Pilkades are regulated in a regional regulation KSB No. 6 of 2016 concerning PPPKD and its implementing regulations. However, in the settings there are inconsistencies, multiple interpretation and antinomy norm. With the MPS Pilkades arrangement that Thus, it is vulnerable to the regulatory basis for implementation settlement of disputes over the results of the Village Chief Election whose direction will be correlated with the intertwined social integrity of the village community so far within the framework of the Unitary State of the Republic of Indonesia. Implementation of regulations regarding existence, position and authority MPS Pilkades, still cannot accommodate and provide certainty law on the implementation of its duties, functions and authorities. Though Thus, in the trial process held by the MPS Pilkades in 2016 and in 2019, able to solve effectively and efficient while still prioritizing the values of local wisdom West Sumbawa Indigenous people. The intended form of reinforcement is to make the MPS Pilkades a solution to the dispute over the results Election of Village Chiefs in Regencies/Cities throughout Indonesia, characterized by the values of local wisdom which are the way of life society in accordance with Pancasila as the philosophy of the Indonesian state with the motto Bhinneka Tunggal Ika to maintain harmony, social harmony and integrity in the village community. Therefore, MPS Pilkades arrangements need to be harmonized with legal principles establishment of good laws and regulations as regulated in Law No. 12 of 2011 concerning the Establishment of Legislation.
