PENERAPAN PRINSIP ENAM BENAR PEMBERIAN OBAT OLEH PERAWAT DI RUANG RAWAT INAP

(ix + 45 halaman: 1 bagan; 10 tabel; 6 lampiran)

Enam benar merupakan prinsip yang harus diperhatikan oleh perawat dalam pemberian obat untuk menghindari kesalahan pemberian obat dan keberhasilan pengobatan. Penelitian ini bertujuan melihat penerapan prinsip enam benar pemberian obat oleh perawat di ruang rawat inap. Penelitian ini menggunakan tipe penelitian kuantitatif deskriptif. Populasi pada penelitian ini adalah semua perawat pelaksana di ruang Bethesda I dan Bethesda II berjumlah 34 orang. Pengambilan sampel dengan menggunakan total sampling berjumlah 34 orang dari ruang rawat inap RSU Siloam Kupang. Penelitian ini dilakukan selama dua minggu dengan cara mengobservasi sample tanpa diketahui untuk memperoleh data deskriptif tentang penerapan prinsip enam benar pemberian obat yaitu benar pasien, benar dosis, benar obat, benar cara pemberian, benar waktu dan benar dokumentasi. Penelitian ini mendapat persetujuan dari *Research Community Service & Training Commitee* (RCTC) Fakultas Ilmu Keperawatan Universitas Pelita Harapan. Penelitian ini dianalisis menggunakan analisis deskriptif. Hasil penelitian menunjukkan dari 34 responden perawat, yang melakukan pemberian obat dengan prinsip benar pasien 14 (41.2%), benar dosis 31 (91.2%), benar obat 33 (97.1%), benar waktu 8 (23.5%), benar rute 34 (100%) dan benar dokumentasi 34 (100%). Penelitian selanjutnya diharapkan dilakukan penelitian mengenai faktor penyebab rendahnya tingkat penerapan benar pasien dan benar waktu.

THE APPLICATION OF THE SIX CORRECTED MEDICINE

DELIVERY PRINCIPLE BY NURSE IN THE MEDICAL WARD

The principle of six correct is a principle that the nurses must pay attention to avoid mistake in prescribing medicine and for the success of treatment. This study aims to delivery by nurses in the medical ward. This research used descriptive-quantitative research type. The population in this study were all nurses in the Bethesda I and Bethesda II room, there are 34 people. For the sampling used was total sampling with the total of 34 nurses from medical ward at Siloam Hospital Kupang. This study was conducted for two week by observing samples without prior notice to obtain descriptive data on the application of the six correct medicine, correct way of giving correct time and correct documentation. This research has been approved from Research Community Service and Training Committee (RCTC) Faculty of Nursing at Pelita Harapan University. This research was analyzed using descriptive analysis. The results of the study showed that 34 respondents of the nurses, who administered the drug with the correct principle of patient 14 (41.2%), correct dose 31 (91.2%), true drug 33 (97.1%), true time 8 (23.5%), true route 34 (100%) and correct documentation 34 (100%). Further research is expected to be conducted on the factors causing the low level of correct application of the patient and correct time.
